ANNOUNCEMENT OF OFFER PRICE AND ALLOTMENT RESULTS

SUMMARY

Offer Price and net proceeds

- The Offer Price has been determined at HK\$1.34 per Offer Share (excluding brokerage fee of 1.0%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%).
- Based on the Offer Price of HK\$1.34 per Offer Share and the total number of 50,000,000 Offer Shares, the net proceeds from the Share Offer to be received by the Company, after deducting the underwriting fees and estimated expenses payable by the Company in connection with the Share Offer, is estimated to be approximately HK\$48.6 million. The Company intends to apply such net proceeds in the manner set out in the paragraph headed “Offer Price and net proceeds” below in this announcement.

Applications under the Public Offer

- A total of 18,489 valid applications have been received pursuant to the Public Offer on **WHITE** and **YELLOW** Application Forms and by giving **electronic application instructions** to HKSCC via CCASS and to the **HK eIPO White Form** Service Provider through the **HK eIPO White Form** service for a total of 3,070,160,000 Public Offer Shares, representing approximately 614.03 times of the total number of 5,000,000 Public Offer Shares initially available for subscription under the Public Offer.
- Due to significant over-subscription in the Public Offer, the reallocation procedures as described in the paragraph headed “Reallocation of the Offer Shares between the Public Offer and the Placing” under the section headed “Structure and conditions of the Share Offer” in the Prospectus have been applied.
