POLL RESULTS OF THE ANNUAL GENERAL MEETING HELD ON 8 JUNE 2026

MS Group Holdings Limited (the “**Company**”) announces that at its annual general meeting held on 8 June 2026 (the “**AGM**”), all the proposed resolutions set out in the notice of the AGM dated 16 April 2026 (the “**AGM Notice**”) were passed on a poll.

As at the date of the AGM, the total number of issued shares of the Company (the “**Share(s)**”) was 204,400,000, representing the total number of Shares entitling the holders to attend and vote for or against the resolutions proposed at the AGM. There were no shareholders of the Company (the “**Shareholder(s)**”) entitled to attend and abstain from voting in favour of any resolutions proposed at the AGM as set out in Rule 13.40 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) nor was any Shareholders required under the Listing Rules to abstain from voting at the AGM. All directors of the Company (the “**Directors**”) attended the AGM in person or by electronic means.
